
2. Professor Susan Flader


3. Professor Ranjan Chakrabarti


Professor Ranjan Chakrabarti (MA, Ph.D. JU, Cal.) is currently Professor of History (formerly Professor and Head) at Jadavpur University, Kolkata, India. Professor
Chakrabarti, is one of the earliest scholars in India to undertake research in the history of crime, criminality, protest and environmental history of colonial India. Besides a large number research articles in learned national and international journals and edited volumes, he has authored *Authority and Violence in Colonial Bengal* (1998).
Professor Chakrabarti's other major publications include *Terror, Crime and Punishment* (Kolkata: Readers Service, 2010), *Situating Environmental History* (Delhi: Manohar, 2007), *Does Environmental History Matter*? (Calcutta: Readers Service, 2006), *Random Notes on Modern Indian History* (Calcutta: Readers Service, 2006 and 2008).

Association of (or for) East Asian Environmental History (AEAEH) Bylaws (draft)

Statement of Objectives

The objectives of Association for East Asian Environmental History (AEAEH) are:

- to encourage, promote, and foster the study of East Asian environmental history in general;
- to foster communication among scholars interested in East Asian environmental history and related disciplines through biennial conferences;
- to foster communication with scholars interested in environmental history and related disciplines in other parts of the world by participating in the activities of the International Consortium of Environmental History Organizations (ICEHO).
- English shall be used in correspondences and conferences to facilitate communication.

1. Membership

- 1.1 Membership of the AEAEH is open to any person interested in environmental history or related disciplines who supports the Objectives of the AEAEH. Membership shall not be restricted on the basis of residency or citizenship.
- 1.2 Membership categories shall consist of (a) regular members, (b) student members, and (c) other classifications of membership as may hereafter be established.
- 1.3 Members who attend the AEAEH biennial conference and pay the associated registration fees are considered Active Members and shall have the right to vote at the General Meeting of the Association (GMA).

2. Officers and Responsibility

- 2.1 Only Active Members are eligible to vote and hold office.
- 2.2 For the present officers of the Association shall include President, Vice-President, and Regional Representatives. In due time, the positions of Secretary, Treasurer and other officers deemed necessary shall be added.
- 2.3 The President shall be charged with organizing the biennial conference of the Association. He/She shall appoint members of local organizing committee and program committee, and shall be an ex-officio member of all committees of the Association. In case of the President's absence or inability to act, the Vice-President shall discharge the duties of the President.
- 2.4 The Vice-President shall assist the President in arranging the Association's

biennial program. He/She shall act on behalf of the President in all matters when the President is absent or unable to act.

- 2.5 Regional Representatives shall assist in disseminating information to regional membership and assist in maintaining timely announcements and other information to the Association website.
- 2.6 The President and Vice-President shall be from the same region to facilitate preparation of the biennial conference. Both positions shall be nominated and elected at the General Meeting of the Association (GMA) by Active Members in the biennial conference and shall assume office immediately at the conclusion of the GMA. Both officers shall hold office for a term of two years and shall not be reelected after serving the first term, but candidates from the same region can be reelected after an interval.

(This is to encourage regions to take turns and to have biennial conferences occur at different places.)

2.7 Regional Representatives shall be recommended by members of the respective regions and approved by the GMA in the biennial conference. Each region shall have one representative.

(For the definition of region, see appendix.)

3. Meetings

- 3.1 The Association shall plan and sponsor biennial conferences devoted to scholarly exchange.
- 3.2 The GMA shall occur during the biennial conference to elect President and Vice-President, and to approve recommendations of Regional Representatives.
- 3.3 As situations warrant, the President may call emergency meetings of with stated purpose.

4. Dues

- 4.1 No annual membership dues shall be required. Beginning from the second biennial conference, the local organizing committee shall determine conference registration fees (students with reduced fees).
- 4.2 The registration fees shall cover a portion of expenses of the biennial conference.

5. The Association's Website

- 5.1 The Association's website of <u>http://www.aeaeh.org/</u> was established by Academia Sinica expedite AEAEH membership in the ICEHO. This website was approved on September 11, 2009 for ten years. It shall be maintained by Academia Sinica.
- 5.2 The GMA shall approve renewal of website management.

6. The Membership of ICEHO

6.1 The annual dues (US\$50) to maintain AEAEH membership in the ICEHO shall be paid by the Institute of Taiwan History, Academia Sinica, from the budget allocated for environmental history research.

7. Additions and Amendments

- 7.1 Proposed additions and/or amendments to the bylaws must be submitted to the President in writing, signed by three or more members, at least 90 days prior to the AEAEH biennial conference. It is required to have at least 50% of Active Members present and voting at the GMA; if approved by two-thirds, the change shall then take effect.
- 7.2 In case of urgent need, proposed additions and/or amendments to the bylaws may be submitted to the President in writing, signed by three or more members. The President shall then ask the opinion of members through email correspondence. If approved by two-thirds of members responded, the change shall then take effect and be subsequently endorsed by the GMA during the biennial conference.

Title: Journal of East Asian Environmental History

Aims and Scope

The aims of the journal would largely reflect the aims of the Association for East Asian Environmental History (http://www.aeaeh.org/index.htm), which are

- 'to encourage, promote and foster the study of East Asian environmental history,'
- 'to foster communication among scholars with an interest in East Asian environmental history,' and
- 'to foster communication with scholars interested in environmental history and related disciplines more generally.'

These aims could be forcefully supported through a journal edited under the auspices of the association and published by a major academic publisher with an efficient marketing and distribution network. **Brill** (Leiden) has indicated a strong interest in publishing such a journal, which can be regarded as a major asset for the future work of the association. Through the publication of a specialized journal the field would gain enormously in visibility and thus would help to raise the profile of the Association in particular and East Asian environmental history more generally.

These aims can be reached through the publication of first-class studies, which may include translations of outstanding scholarly work written in languages other than English, reviews, reports and other content relating to current developments and activities in the field of East Asian environmental history with all its relevant sub-disciplines. More and more environmental history is going to contain important components of various sciences. It might even be worth considering doing something like the *Nature* summaries of and commentaries on intellectually tough articles for those not up-to-speed on things like various kinds of dating, etc. It might help to have a feature that draws attention to interesting and potentially useful recent contributions in other sectors of environmental history. While the geographic focus of the journal would be the Chinese, Japanese, and Korean-speaking world, in terms of thematic coverage a global perspective and comparative approaches would be encouraged. It should be the task of the journal not only to explore the field and identify current scholarly trends, but even to set agendas and to encourage experimental formats.

The format of the journal itself should be an e-journal, which would allow a continuous flow of publication of contributions, while still being organized in two distinct issues per volume, with the option of print-on-demand. This would make the whole undertaking not only more flexible, more potent (e.g. as far as the inclusion of visual materials is concerned), and easier accessible, but also economically more viable.

A first **problem** that such an undertaking would have to address is the language question. As the Association has declared English as its working language, an English-language journal should not be considered problematic. However, it is important to acknowledge that the majority of current members are from East Asian countries, and the greatest potential of new members may be scholars from these countries who are less comfortable with using academic English. Therefore it would seem appropriate to provide abstracts not only in English, but also in Japanese, Chinese (in both simplified and traditional characters), and probably also in Korean.

Rationale

The major English-language journals in the field of environmental history are the US-based *Environmental History* (http://www.environmentalhistory.net/) published by Oxford University Press and the UK-based *Environment and History* (http://www.erica.demon.co.uk/EH.html) published by the White Horse Press (UK). Both are linked to professional organizations, the American Society for Environmental History and the Forest History Society in the first case, and the European Society for Environmental History in the second case. While both do occasionally publish articles on Asian topics, they can still easily be described as heavily America- and Europe-centred. A new journal with a focus on East Asia and the potential to also cover neighbouring regions to some extent would fill a clear lacuna. By encouraging scholars from East Asian countries to publish in English the journal would also be able to play an important role in making research from East Asia available to a broader English-reading audience not able to read research published in Asian languages and thus greatly enhance the knowledge in the field of global environmental history more generally.

Editorial Structure

The most thorny question may well be: Who will be doing all the work? An editor-in-chief or **managing editor**, who would be ultimately responsible for the academic content of the journal, would certainly be needed. Given the diversity of the academic landscapes covered by the journal, a group of three or four **co-editors** may be adequate. The work of this core group would be supported by the **editorial board**, in which each of the major world regions from which the membership of the association is recruited should be represented. Appointments to the editorial board should be made by the editor-in-chief after consultation with the council members of the Association. The suggested regions would be China, Hong Kong, Taiwan, Japan, Korea, Southeast Asia, Australia, North America, and Europe. Editorial board meetings could be held in conjunction with the biannual conference of the Association, as well as at other international conferences as adequate.

Brill would be responsible for the **production** side and provide a whole range of services that will help to ease the process, such as their online management system.

Copy editing and language editing may need a separate source of funding.

Concerning the **peer review** process, it could be considered to adopt an open format, which would include signed reviews and the inclusion of the pre-publication history of each paper in the published version. While this may be a step too far for many scholars in the humanities, the option to include authors' responses should certainly be made available for the review section. This would be a good way to get controversies going, for which again, the electronic format is better suited than a print journal.

In order to handle the administrative business of the journal (on the academic side), such as the communication with authors and reviewers, an **institutional basis** would have to be found, ideally with the support of a 0.5 secretarial position. Academia Sinica may be an obvious suggestion, though other candidates would certainly also be possible.

Target Audience, Market Potential, and Funding

The target audience would be first of all the members of the association (currently around 250). Perhaps more importantly, the demand for a reputable electronic + print-on-demand journal from libraries around the world would certainly double the demand from the present membership, and maybe by far more.

It would have to be discussed whether or not the Association would agree to raise a **membership fee** (e.g. \notin 40) that would include free access to the journal and pay towards its costs. Brill would offer a nominal fee (ca. \notin 1500) to help cover editors' costs. The funding for the secretarial staff mentioned above, however, remains

unclear. Advertising, not only for books, but perhaps even for environmental travel may be a further source of income.

Timing

It may be possible to draw on the contributions to the 2011 conference for the first volume of the journal that could be scheduled to appear in 2013 – depending of course on the current plans of the organizers of the conference.
